AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF HADDONFIELD, COUNTY OF CAMDEN, STATE OF NEW JERSEY, CHAPTERS 232 ENTITLED VEHICLES AND TRAFFIC FOR VARIOUS ITEMS

BE IT ORDAINED BY the Board of Commissioners of the Borough of Haddonfield, County of Camden, State of New Jersey, as follows:

SECTION I

1. Chapter 232, entitled Vehicles and Traffic, Article V – Traffic Regulations, Section 232-31, entitled Handicapped Parking is hereby amended to include the new spaces named below:

§ 232-31. Handicapped Parking

- A. Handicapped parking on street. In accordance with the provisions of N.J.S.A. 39:4-197, the following on-street locations are designated as handicapped parking space. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Division of Motor Vehicles, or a temporary placard issued by the Chief of Police. No other person shall be permitted to park in these pages.

Street	Number of Spaces	Location
N. Haddon Avenue	1	West side, beginning 425 feet south of Euclid Avenue along the western curblineline to a point 20 feet north thereof

- B. Handicapped parking in municipal parking lots and Board of Education property. In accordance with the provisions of N.J.S.A. 39:4-197, the following off-street municipal parking yards and Board of Education property are designated as handicapped parking spaces. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Division of Motor Vehicles, or a temporary placard issued by the Chief of Police. No other person shall be permitted to park in these spaces.

2. Article V – Traffic Regulations, Section 232-39, entitled Loading Zones shall be amended to include the following:

§232-39. Loading zones

Street	Time	Sides	Location
321 Springfield Terrace	15 Minutes	North	Starting 235 feet in an easterly direction from the intersection of Springfield Terr. & Potter Street along the northern curbline and continuing 20 feet in an easterly direction to its end

SECTION II

All ordinances or parts of ordinances inconsistent with this amending ordinance be and they are hereby repealed to the extent of such inconsistencies only.

SECTION III

If any section or provision of this ordinance shall be held unconstitutional or invalid by any court, the remaining sections and provisions shall, notwithstanding such holding, remain and be in full force and effect.


SECTION IV
