To: Properties abutting Tanner Street (Kings Highway to Euclid Ave)

Re: Planned Utility Improvement Project

The Borough Commissioners have authorized utility improvement work for the full length of Tanner Street. The utility work will consist of replacement of a new eight inch water main, replacement of a new twelve inch PVC sewer main and a new stormsewer system including new inlets.. This work will also include the replacement of the old sewer laterals and water services to each property in the work area.

PACT Construction, of Ringoes, NJ will be the Borough's contractor for the work. They began on September 15<sup>th</sup>. As always, the schedule is based upon good weather. The contractor began with the replacement of the water main from Euclid Ave along Tanner to Kings Highway. Once this has been completed and all water services have been transferred to the new main, the contractor will then begin replacement of the storm and sanitary lines. This work will again begin at the Euclid Ave end of Tanner. The contractor will notify each homeowner prior to disrupting your current water or sewer service and it is expected that this inconvenience will only last a short time. If you have been noticed that your water has been shut off we suggest that you run your clothes washer through one cycle, without clothes, to ensure that any debris has been removed from the lines.

Roads will be closed to local traffic only during the construction period. Traffic patterns may change throughout this project. We will do our best to notify you in advance of the change. We will also provide the appropriate detour map on our website. It is possible that one lane may be closed down during a portion of the project. On street parking will not be allowed during the workday on the block(s) the contractor is working on. Cars must be off the road by 7:00 a.m. The Police Department is aware of this situation and will relax enforcement of the overnight parking regulations where appropriate. If you have any concern, please call 784-9161 for overnight parking permission. Trash and recycling will continue to be picked up on your normal day. The contractor; however, has requested that all trash and recycling be picked up no later than 7:30 am, which may be earlier than you are accustomed to.

It is anticipated that the work will be completed by mid-November. This is only for the utility portion of the project. Your patience and understanding during this sometimes messy process will be appreciated. The end result for the long term should be worth the short-term trouble construction work always causes.


