AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF HADDONFIELD, COUNTY OF CAMDEN, STATE OF NEW JERSEY, CHAPTER 226, ENTITLED UTILITIES, WATER AND SEWER, TO FIX AND ESTABLISH THE RATES FOR THESE SERVICES FURNISHED BY THE BOROUGH OF HADDONFIELD

WHEREAS, these increases will take effect with the second billing cycle in 2011.

THEREFORE, be it ordained by the Board of Commissioners of the Borough of Haddonfield, County of Camden, State of New Jersey, as follows:

SECTION I:

Chapter 226, Sections 16(A), 17(A) and 18 of the Code of the Borough of Haddonfield hereby be amended to read as follows:

§226-16. Water rates.

- A. The rates to be charged by the Borough of Haddonfield for water produced by the Borough shall be **\$4.80** [~~\$4.70~~] per thousand gallons to be charged to customer for water which is furnished to a property as calculated from the meter reading or estimate used for billing beginning with the second quarter mailing.

§226-17. Sewer service rates.

- A. The rate to be charged by the Borough of Haddonfield for sewer service shall be **\$2.30** [~~\$2.25~~] per thousand gallons of water furnished to a property as calculated from the meter reading or estimate used for billing beginning with the second quarter mailing.

SECTION II:

All ordinances or parts of ordinances inconsistent with this amending ordinance be and they are hereby repealed to the extent of such inconsistencies only.
