AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF HADDONFIELD, COUNTY OF CAMDEN, STATE OF NEW JERSEY, CHAPTER 226, ENTITLED UTILITIES, WATER AND SEWER, TO FIX AND ESTABLISH THE RATES FOR THESE SERVICES FURNISHED BY THE BOROUGH OF HADDONFIELD

WHEREAS, these increases will take effect with the second billing cycle in 2011.

THEREFORE, be it ordained by the Board of Commissioners of the Borough of Haddonfield, County of Camden, State of New Jersey, as follows:

SECTION I:

Chapter 226, Sections 15(B) of the Code of the Borough of Haddonfield hereby be amended to read as follows:

§226-15. Fee Schedule.

B(1) No use of Borough water or sanitary sewer facilities shall be allowed until a meter has been installed and payment made to the Tax Collector's Office according to the following schedule:

Meter Size	[Indoor Remote²]	[Pit Setting]
5/8-inch	\$305.00	[\$330.00]
3/4-inch	\$380.00	[\$405.00]
1-inch	\$425.00	[\$450.00]
1-1/2-inch	\$650.00	[\$695.00]
2-inch	\$875.00	[\$915.00]
3-inch and over	Actual Meter¹ Cost	[Actual Cost¹]

NOTES:

¹All meters larger than two inches shall be installed by the owner under Borough supervision at locations approved by the Borough. The meters shall be supplied by the Borough and delivered to the contractor at the water plant. An inspection fee of \$200 shall be paid before the meter is released to the contractor.
