By initialing next to each line Applicant acknowledges and agrees to comply with the following terms and conditions of approval:

**Note: The following list is not necessarily an exclusive listing of all terms and conditions, which may apply to a given display of merchandise. Applicant is required to comply with all terms and conditions of approval in addition to those terms and conditions set forth in the Land Development Ordinance of the Borough of Haddonfield.**

1. The display of merchandise shall be decorative and shall represent goods sold within the store.
2. If clothing is to be displayed, only such clothing as can be worn by one (1) mannequin shall be displayed.
3. The display of merchandise shall be no greater than thirty (30) inches deep and no greater than eight (8) feet wide.
4. The applicant shall maintain a safe, continuous, four (4) foot wide path for pedestrian traffic to pass in front of the merchandise display
5. No item displayed shall be higher than eight (8) feet above the surface of the sidewalk.
6. The display shall not contain any lighting whatsoever.
7. The display shall not contain any signage whatsoever.
8. All temporary, removable supports used to display merchandise shall be removed from the public right-of-way at the end of each business day.
9. No temporary, removable support shall have wheels except for decorative carts.
10. No cardboard boxes, card tables, folding tables, or similar display supports shall be used as part of a merchandise display.
11. No sales or transfers shall occur outside of the store displaying merchandise.
12. By displaying merchandise Applicant forfeits his right to also operate an Outdoor Eating Facility.
13. The applicant shall provide a Certificate of Insurance ensuring that the applicant has reasonable insurance covering the display of merchandise and naming the Borough of Haddonfield as an additional insured.

**NOTE:** A "**COMPLETE**" Merchandise Display Application **REQUIRES** five (5) copies of the following

1. Five completed Merchandise Display Application Forms;
2. Drawings, or plans, of the proposed display area drawn to scale:
  - (A) with appropriate dimensions depicted thereon;
  - (B) depicting the area from the façade of building to the curb;
  - (C) depicting all items within the public right-of-way; and,
  - (D) depicting the location of the storefront entrance.
3. Proof that applicant has reasonable insurance covering the merchandise display and naming the Borough of Haddonfield as an additional insured; and,
4. The Initial Application Fee of \$50.00 (FIFTY DOLLARS); or,
5. The Renewal Application Fee of \$25.00 (TWENTY-FIVE DOLLARS).
