AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF HADDONFIELD, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AMENDING CHAPTER 23 ENTITLED EMERGENCY MEDICAL SERVICES FEES TO CHANGE THE FEES CHARGED

BE IT ORDAINED BY the Board of Commissioners of the Borough of Haddonfield, County of Camden, State of New Jersey, as follows:

SECTION I:

- Chapter 23, entitled Emergency Medical Services Fees, Section 23-6, entitled Fees and billings shall be amended as follows:

§23-6 Fee and billings.

- Billings to insurance companies and/or persons provided emergency medical services. The Haddonfield Ambulance Association shall bill, or contract with a third-party billing agent to bill the amount of \$~~[450]~~ **600** plus the cost of reimbursable supplies and equipment in each instance where EMS services are provided and not covered by an advanced life support transport agreement.
- ~~[Part of annual fee ordinance. Said fees as outlined in Subsection A shall be incorporated in the Borough Fee ordinance, and such fees may be modified in such Borough Fee Ordinance.]~~ **Additionally, where applicable, a loaded mileage fee of \$15 per mile to transport a patient to the hospital shall be applied.**
- Said bill shall be issued to the patient and the insurance company providing coverage for the patient, with the patient's consent.

SECTION II:

All ordinances or parts of ordinances inconsistent with this amending ordinance be and they are hereby repealed to the extent of such inconsistencies only.

SECTION III:

If any section or provision of this ordinance shall be held unconstitutional or invalid by any court, the remaining sections and provisions shall, notwithstanding such holding, remain and be in full force and effect.

SECTION IV:

This ordinance shall be in effect upon passage and publication according to law.
